On behalf of the Nominating and Governance committee, M. Pitcher provided a verbal report, in addition to the *Draft* April 25, 2018 OPEN minutes as circulated.

PRESENTATION: Partnership Advancements

President Vezina shared an update on progress being made on various aspects of the AU/SKG partnership. Vezina noted that some of the recent developments have come from the re-establishment of a regular meeting schedule for the Joint Working Group. As part of her presentation she highlighted the current AU/SET Covenant and the recently developed Addendum to the Covenant that has been written as a collaborative effort between AU and SKG. The addendum will recognize Algoma University formerly known in the covenant as AUC (Algoma University College) and also describes the evolution of Shingwauk Kinoomaage Gamig as written with the assistance of Elders, and vetted through the JWG. S. Horn suggested that the Addendum should reflect AU's special mission as well.

Once approved by both Boards, there will be a special ceremony to honor the signing.

Board Executive

Joint Work Group (JWG)- Terms of Reference (TOR). The Board received a Board note outlining the background and current status of the TOR for the JWG. The JWG had been working under a draft terms of reference while it was being revised. The terms of reference has been reviewed by various stakeholder groups from the university and SKG and is now before the Board for approval.

Nomination and Governance

2018-19 Board and Board Committee Calendar (Draft)- M. Pitcher, Chair of the NG Committee, explained the rationale behind the meeting calendars being presented to the Board.

Pitcher noted that NG has drafted a 6 per year meeting schedule starting in September 2018 (Option #1), and noted that should Board business require it, the Chair can call a special meeting.

The second version, option #2, as presented to the Board includes an additional two meetings in Oct and Feb that would focus the Board's attention on strategic planning, university advancement and governance.

The annual Retreat has been scheduled once again for January 2019.

After some discussion at the Board table, it was determined that there was preference by Board members to move forward with Option #2. NG will now move forward with populating the proposed calendar with the Board Committee meetings and will have it ready for the next Board meeting.



NEW BUSINESS ITEMS

Aboriginal Institutes - Introduction (Vezina)

Shingwauk Kinoomaage Gamig has recently been approved as one of nine Aboriginal Institutes by the provincial government. This will eventually authorize SKG to become an independent degree granting university.

SKG and AU are working collaboratively to determine how to best move forward in partnership, as there are many opportunities in the forefront. In a recent visit by the Ministry of Advancement and Education, who meet with representatives from AU and SKG, there was a lot of positivity surrounding our partnership and the relationship.
