Decisions

Senate Minutes

The Senate passed the open minutes of the December 6, 2024 meeting of the Senate.

Changes to Senate Membership

The Senate approved a revised Senate membership slate. The following appointment was approved:

Dr. Paulette Steeves, Faculty Chair, Faculty of Cross-Cultural Studies (January 1, 2025 to June 30, 2025)

Senate Committee Membership

The Senate approved the following changes to the Senate Committee membership slate:

- The appointment of Dr. Paulette Steeves to the Academic Planning and Priorities Committee and the Senate Executive Committee.
- The appointment of Dr. Edward Turgeon as an alternate member from the Faculty of Humanities and Social Sciences to the Appeals and Academic Standards Committee.
- The amendment of the slate to reflect Michael Graydon's resignation as a member of the Faculty of Cross-Cultural Studies from the Appeals and Academic Standards Committee.

The Senate approved revisions to the Disciplinary Regulations on Academic Integrity Policy as recommended by the Appeals and Academic Standards Committee.

The Senate approved the Report on the Status of the Implementation Plan (18-Month Status Report) for the Visual Arts Program, 2020/21 Cyclical Program review as submitted.

Curriculum Modifications

The Senate approved the proposed substantial Major Modification to the BSc Computer Science Program as presented by the Faculty of Computer Science and Technology, as recommended by the Quality Assurance Committee and the Academic Planning and Priorities Committee.

Change of Field for Approved Faculty Position: Faculty of Computer Science and Technology

The Senate recommended to the President and Vice-Chancellor the change of field of an approved Faculty of Computer Science and Technology faculty position from XR/IT to Mathematics as recommended by the Academic Planning and Priorities Committee.
